



## RX-8 Nationals 2007

5<sup>th</sup> – 7<sup>th</sup> October 2007

Thank you for your interest in the 2007 Mazda RX-8 Nationals weekend being held at Winton Motor Raceway [www.wintonraceway.com.au](http://www.wintonraceway.com.au).

In their 3<sup>rd</sup> year, the Nationals are intended to bring together fellow enthusiasts of the Mazda RX-8 to appreciate the many facets of the car. This year we again have some major involvement from Mazda Australia who will have a large marquee with marketing and technical staff as well as instructors from Driver Dynamics. You will be able to see (and take rides in) some forced induction cars from ProMaz in Melbourne, REVS in Adelaide and the 270Kw Mazda Extreme Concept RX-8. You will also see a number of RX-8 show cars.

### Itinerary

The weekend will start on Friday with checking in at the Trekkers Rest. We will then head down to the local pub for dinner. After dinner we will have the drivers briefing where full details on how things will run the next day will be outlined. Its very straight forward so don't stress out.

Saturday morning will start with a light continental breakfast at the Trekkers Rest. From there we will head over to Winton Raceway. A few laps around Winton will be followed by a hot Lunch at the Winton Cafeteria. Lunch will be followed by a few more laps around Winton. We will leave Winton around 4pm and head back to the Trekkers Rest, freshen up and head to the Dinning area for a nice Roast Dinner.

Sunday Morning we will have a late rise and head into town where we will be having a nice hot breaky and coffee at one of the local eateries. From there we will conclude the event.

### Track Day Details

The main event is a High Speed Driver Education day organised in conjunction with Mazda Australia and driving instructors from Driver Dynamics ([www.driverdynamics.com.au](http://www.driverdynamics.com.au)).

The purpose of the event is to bring together owners of the RX-8, and as a result the event is aimed at owners of the RX-8, their family and friends. Entry to people who don't own an RX-8 is at the discretion of the **OzRenesis** committee. Track participants will be limited to 40 people.

The fees for the Event are as follows:

- *Non-track participant* \$150  
Includes food & accommodation
- Track participants \$450  
Includes food, accommodation, track hire...

A deposit of \$150 per booking is required by 23<sup>rd</sup> July 2007 to secure your position. The remainder of the fees will be due by 27<sup>th</sup> August 2007.

No entry is finalised until full payment is received and confirmed by the **OzRenesis** Event Coordinator. **OzRenesis** reserves the right to refuse any application.

Saturday will commence at 08:30 sharp with scrutineering. Scrutineers will be looking for general roadworthiness of vehicles such as:

- Tyre and suspension condition;
- Working, undamaged seat belts and/or safety harnesses;
- An effective muffler that emits no more than 95 dB(a); and
- The absence of loose or removable items such as tools, jacks, spare wheels, etc

Generally speaking, if a vehicle is not roadworthy it's not trackworthy. Any vehicle that is not signed off by a scrutineer will not be permitted on the track. Decisions as to whether or not a vehicle is roadworthy rest solely with the scrutineers and no debate will be entered into.

Scrutineering will be followed at 09:00 by a 30 minute compulsory participant briefing. All participants will be required to:

- Supply a copy of the **“Exclusion of Liability, Release and Assumption of Risk”** section of this document with all relevant areas filled in. The document must be signed and each page initialled **in front of an OzRenesis Official. DO NOT sign this before hand.**;
- Present a helmet complying with AS1698 or better;
- Be wearing non synthetic clothing covering all limbs (including fully enclosed footwear); and
- Present either a current AASA license or current CAMS L2S license.

Anyone that is not present for this briefing or scrutineering may be required to pay a \$100 late fee to cover the time required to brief and scrutineer them individually or will not be permitted to participate.

**Any attempt to circumvent scrutineering or the driver briefing will result in the participant being excluded from the day and forfeiting their Fee.**

The day will run in groups (maximum of 10 in each group) based on experience. Drivers may ask the Officials on the day to be regrouped during the day. However, decisions as to grouping of cars and drivers rests solely with the Officials.

Sessions will consist of 15 minutes of laps of the course, plus a cool down lap. The first car of the next group will be flagged onto the track once the last car from the previous group enters pit lane.

The sessions will be directed using the start/finish line lights and a set of standard motor racing flags at pit exit.

Flags will be as follows:



Blue - Slow right down and let faster driver(s) overtake at the next straight.

Yellow - Caution, danger on track. You **MUST** slow down to 60km/h or less.

Red - Session is over. You **MUST** exit at your next approach to pit lane entry.

Checkered - Session is over. You **MUST** exit at your next approach to pit lane entry.

**Failure to comply with course directions will result in exclusion from the remainder of the day.**

The day is a strictly non-alcohol event. Participants must have a blood alcohol level of 0.000 at all times during the meeting. **OzRenesis** reserves the right to require a participant to undergo a blood alcohol breath test to determine the participant's compliance with this requirement.

**Failure to comply with this requirement will result in exclusion from the remainder of the meeting.**

DO NOT sign the “Exclusion of Liability, Release and Assumption of Risk” section. You must do this in front of an OzRenesis Official on the day.

Please **print out** and fill in the **“Entry Form”** section and forward to the **OzRenesis** Event Coordinator via Postal mail or fax with your payment details by the required dates. Electronic copies if the Entry Form will NOT be accepted.

## Exclusion of Liability, Release and Assumption of Risk

I agree to indemnify and keep indemnified the *Associated Entities* on demand against any claim, loss, damage, cost or expense incurred or sustained by any or all of the *Associated Entities* as a consequence of any act, matter or thing done, permitted or omitted to be done by any of the *Associated Entities* which arises out of or is in any way connected with my presence at *the Event* or my participation in *the Associated Activity*.

This release and indemnity is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable terms or conditions in respect of *the Event*.

A term of this release and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

My participation in *the Event* and my involvement in *the Associated Activity* is voluntary, however I acknowledge that if I withdraw my presence from *the Event* or my involvement in *the Associated Activity* at any time, a refund of my entry fee is at the sole discretion of the *Event Organisers*.

I acknowledge that:

- The *Associated Entities* do not make any warranty, implied or express, that *the Event* will be provided with due care and skill or that any materials provided in connection with *the Event* will be fit for the purpose for which they are supplied; and
- The *Associated Entities* do not warrant the skill or abilities of any person using the track during *the Event*.
- *the Associated Activity* has special associated risks including but not limited to risk and injury to myself (including my death, mental or physical incapacity), risk and injury to my property and injury to others.
- There are no facilities for the repair of my motor vehicle and there are no facilities for the removal of my motor vehicle from *the Event* in the case that there is damage that results in the motor vehicle being unfit to drive.
- The risks associated with my presence at *the Event* or involvement in *the Associated Activity* include but are not limited to the risk that I may suffer harm as a result of:
  - Acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in *the Event*;
